1. **All taxes are due and payable on or before March 31st, 2023.**
2. A **discount of 5%** will be applied to residential property, water and sewer tax that is paid in full by **March 31st, 2023.** There will be no discount applied to garbage fees or fire protection fees. (This applies to the **2023 tax fees only**, this will not be applied to any previous balances)
3. Anyone wishing to arrange a payment schedule must contact the Town Clerk prior to **March 31st, 2023.**
4. Accounts in arrears or without a payment schedule in place after **March 31st, 2023,** will be subject to disconnection of water services and/or referral to collection services at Council's discretion.
5. If water service is disconnected due to non-payment of taxes, a re-connection fee of \$50.00 will be levied. If water service is disconnected more than once in a calendar year, re-connection fee will be \$100.00
6. Acceptable payment terms must be arranged prior to service being re-connected
7. Previous year balances owing as of **April 1st, 2023,** will be charged interest of prime + 5%.
